CHANGE OF ZONING**

NOTICE IS HEREBY GIVEN that on October 20, 2016 there has been presented to the Town Board of the Town of Caledonia New York, proposed Local Law No. 3 For The Year 2016. The purpose of this Local Law is to consider an application by Affordable Great Locations for a change of zoning and modification of the existing boundaries of a certain zoning district currently known as a Planned Development District. This expansion will be for a change of zoning from (RR) Agricultural Rural Residential (Tax Parcel #'s (23.-1-21.534, 21.-1-21.535) and (I -2) Heavy Industrial, for Tax parcel (23. -1-10) to Planned Development District (PD). These Parcels are located on Caledonia Avon Road/ Route 5 in the Town of Caledonia. Petitioner is requesting that Section §130-5 of the Code of the Town of Caledonia Zoning Map be amended to extend the boundaries of the existing PD (Planned Development (Tax Map Parcel No.'s 23.-1-12.1, 23.-1-12.2, 23.-1-11, and 23.-1-21.312) to include Tax Map Parcel No. 23. - 1 - 10, Tax Map Parcel No 23.-1-21.534, and Tax Map Parcel No 23.-1-21.535 in its entirety.

A public hearing shall be held by the Town Board of the Town of Caledonia at the Town Hall, located at 3109 Main Street, Caledonia, New York at 8:00 P.M. on Thursday, November 10, 2016 for the purpose of considering public opinion and comment about or concerning Proposed Local Law No. 3 for 2016.

This request has been referred to the NYS DOT, the Livingston County Highway Department, the Town of Caledonia Planning Board and the Livingston County Planning Board. A copy of the proposed Local Law is available for review by the public at the office of the Town Clerk during regular office hours.


Let it be known at such time and place the Town Board will hear anyone who wishes to speak for or against such change of zoning.
